

**Subject:- Restoration of Minimum Rates of wages payable to the daily
rated/contractual employees of DTC.**

The Circular Nos. PLD-V/MW/2018/2885, 2976 & 3041 dated 21.8.2018, 28.8.2018 & 31.08.2018 respectively issued by the PLD are hereby treated as withdrawn with immediate effect. Further, the contents of PLD's earlier circular memo No. PLD-V/MW/2018/1667 dated 24.5.2018 whereby the Minimum Rates of wages in respect of daily rated/contractual employees of DTC were revised w.e.f. 1.4.2018, are hereby restored as per the following rates w.e.f. 05.08.2018 and re-notified as under:-

CIRCULAR

Subject: Payment of wages to the contractual drivers working in DTC

In supersession to this office Order No. PLD-III/MW/Cont. Driver/2018/3049 dated 04.09.2018 and in compliance to the office circular No. PLD-V/MW/2018/3959 dated 28.10.2018 vide which the Minimum wages for Contractual Employees as notified by GNCTD has been restored, the wages to be paid to the contractual drivers performing duties on City/NCR operations in DTC is accordingly revised as per the directions issued by DTC Board vide its Resolution No. 15/2018 in its meeting held on 27.02.2018 with effect from 01.08.2018 and reduced payments made as a result of the orders of Hon'ble High Court of Delhi or if any deductions were made, such personnel shall be paid balance amounts equal to the amount of reduction or deduction for the entire intervening period on or before 31.10.2018. The revised rates are as follow:-

1. Distance driven in a month

First 2250 Km

Beyond 2250 Km Upto 4500 Km

Wages Rate



2. Apart from above, the following amount shall also be payable w.e.f. 01.08.2018 subject to the following:-

- (i). An amount of Rs.2200/- per month be given for achieving 22 days physical attendance and operation of 95% of Scheduled Kilometres and an additional amount of Rs.200/- per day for maximum 04 days for duties beyond 22 days be also paid, thus, the total amount can go upto Rs. 3000/- per month.
- (ii). An amount of Rs.1400/- per month be given for achieving 22 days physical attendance and operation of 85% of scheduled kilometres. An additional amount of Rs. 150/- per day for maximum 04 days for duties beyond 22 days be also paid, thus, the total amount can go upto Rs.2000/- per month.
- (iii). The payment of incentives shall be made to the contractual drivers subject to fulfilment of the following conditions:
 - (a). Incentive will be paid for line duties to the contractual drivers who are deployed on buses only.
 - (b). There should not be any fatal/major accident on the part of contractual driver for payment of incentives in the relevant month.
