





4. NGO not been blacklisted or placed under defaulter funding by any Government Agencies. (Attach an affidavit on Rs.10/-stamp paper)
5. NGO office should be in Delhi.
6. The NGOs should not have any inclination towards any political or religious affiliations. (Attach an affidavit on Rs.10/-stamp paper)
