Subject:- Constitution of State Committee on Electoral Literacy (SCEL) on Main Streaming of Electoral Literacy: Establishment of Electoral Literacy Clubs in School/Colleges and Communities – reg.

In pursuance of Election Commission of India's Letter No. 491/ECI/LET/SVEEP-I/ELC/2017 dated 3rd November, 2017, the State Committee on Electoral Literacy is hereby constituted under the Chairmanship of Chief Electoral Officer, Delhi to supervise the planning, implementation, monitoring and evaluation of the programme within the state as under:-

The objectives for the ELC are as under:-

- To educate the targeted populations about voter registration, entire electoral process and related matters by engaging them through well designed attractive resources in hands on experience;
- EVM and VVPAT familiarisation and education about robustness and non-tamperability of EVM and integrity of the electoral process using EVMs.
- iii. Capacity building for generating/locating information on what, when, where and how of the elections and electoral process right from a young age of around 14 years.
- iv. To help target audience to understand the value of their vote and exercise their suffrage right in a confident, comfortable and ethical manner.
- v. To facilitate the target audience to understand the constitutional, legislative and legal provisions besides the technological innovation and integration in elections and nature and role of the Election Commission, Courts, Media and other stakeholders.
- vi. To harness the potential of ELC members for carrying the electoral literacy in communities.
- vii. ELCs will facilitate voter registration for its members as they achieve the age of 18.

The ELC shall be established as per the following pattern:-

- i. ELC Future Voters- for Classes IX to Class XII (Secondary and Senior Secondary Level)
- ELC New Voters- College, University, all other educational institutions including professional and technical education institutions.
- iii. Chunav Paathshala- ELC in communities for the youth who are not a part of the formal education system.
- iv. Voter Awareness forums- In Government Departments, Organizations, Autonomous Bodies, Semi Government and non government and the private sector.

Functions of the State Level Committee

- The SCEL will be overall in charge of planning, implementation, monitoring and evaluation of the Programme within the state.
- ii. Draw up a calendar and plan of action for setting up of:
- a. The ELCs (Future Voters) in all the Secondary, Senior Secondary Schools.

- b. The ELCs (New Voters) in colleges, universities and other education institutions.
- c. The ELCs (Communities) for those young people who have dropped out of school or college
- d. Voter Awarencess Forums in the State.
- iii. Prepare lists of State Master Traniners. These trainers will undergo training as per schedule prepared by the Commission.
- iv. Organize and develop calendar of training for the state with specific timelines.
- v. Prepare a district wise codified list of ELCs in the state with a view to monitor the establishment of the ELCs in each of the institutions across the respective states.
- vi. Prepare a list of non partisan/neutral NGOs/CSOs who can be associated with establishing the ELCs especially the ELC (Communities)/Chunav Pathshala.
- Vii Translate and adapt the ECI provided Student-Teachers resources for use at ground level.

 Disseminate to the Districts.
- viii. Collect or arrange to collect information on innovation, develop documentation and forward the same to the SVEEP, ECI for consideration.

Madam/Sir,

In pursuance of the recommendations given in the Commission's report on 'Mainstreaming of Electoral Literacy through Educational Institutions, Organizations' which has already been sent to you, the Commission has directed for setting up of Electoral Literacy Clubs (ELCs) in educational institutions and communities not covered under the formal education system to engage future and new voters through extracurricular interventions.

- 2. 'Project Document on Electoral Literacy Clubs in India' in this regard is attached (Annex I) for guidance and follow up. Additional copies for DEOs are also being sent and may be sent onwards with a covering letter on similar lines. The first batch of ELCs shall be rolled out on the 8th NVD i.e. 25th January 2018, and accordingly steps may be taken up for the same.
- 3. ELCs shall be the seat of learning through hands on experience and shall serve as a vibrant hub of Electoral Literacy for developing and strengthening the culture of electoral participation among young and future voters.

3.1. Objectives

- (i) To educate the targeted populations about voter registration, entire electoral process and related matters by engaging them through well designed attractive resources in hands on experience;
- (ii) EVM and VVPAT familiarisation and education about robustness and non-tamperability of EVM and integrity of the electoral process using EVMs.
- (iii) Capacity building for generating/locating information on what, when, where and how of the elections and electoral process right from a young age of around 14 years.

- (iv) To help target audience to understand the value of their vote and exercise their suffrage right in a confident, comfortable and ethical manner.
- (v) To facilitate the target audience to understand the constitutional, legislative and legal provisions besides the technological innovation and integration in elections and nature and role of the Election Commission, Courts, Media and other stakeholders.
- (vi) To harness the potential of ELC members for carrying the electoral literacy in communities.
- (vii) ELCs will facilitate voter registration for its members as they achieve the age of 18.

3.2. The ELCs shall be established as per the following pattern:

- (i) **ELC Future Voters** for Classes IX to Class XII (Secondary and Senior Secondary Level)
- (ii) **ELC New Voters** College, University, all other educational institutions including professional and technical educational institutions
- (iii) Chunav Paathshala ELC in communities for the youth who are not a part of the formal education system
- (iv) Voter Awareness Forums In Government Departments, Organizations, Autonomous Bodies, Semi Government and non government and the private sector

3.2,1. ELC Future Voters

Electoral Literacy Clubs will be set up in Secondary and Senior Secondary Schools. The club will have students of Class IX-XII as its members. Students may be encouraged to run the ELC through an elected body of Executive Committee with elected representatives from each of the Sections. Alternatively School may conduct the activities through teachers involving the students.

One or two teachers, preferably from the Humanities Department will act as the Nodal Officers and Mentors for the ELC. The teachers with election duty experience should be given preference for this work. Their duties and responsibilities shall be as detailed at 4.1. in the Project Document.

3.2.2. ELC New Voters

Electoral Literacy Clubs will be set up in colleges and university campuses for engaging students in hands on experience in electoral literacy. Guidance and involvement of teachers especially those who have experience of election duties will be an important component. The club will have students as its members and would be run by an Executive Committee from amongst the students with elected representatives from each of the Classes. Campus Ambassador will act as the Convenor of the ELC and will assist the Nodal Officer in discharge of their functions.

One or two teachers, preferably from the Political Science Department etc will act as the Nodal Officers and Mentors for the ELC. The duties and responsibilities of the Nodal Officers and the Executive Committee shall be as detailed at 4.2. in the Project Document.

3.2.3. Chunav Pathshala

Electoral Literacy Clubs will be set up at the Polling Station level catering to those outside the formal education structures and may be named as per the name of the polling station or a group of polling stations. These shall be called Chunav Pathshala.

The BLO will act as Nodal Officer for the Chunav Pathshala and the BAGs shall support and guide the ELC and shall assist the BLO in making the Chunav Pathshalas functional and for enrolling members. Voluntary help by teachers, non-partisan CSOs, NLM functionaries, Panchayat officials or the Municipal officials (Non elected) of that Polling Station area may be taken for enrollment.

The Venue of the 'Chunav Paathshala' shall be Polling Station in the last Lok Sabha or the Assembly Election or any other venue identified by the BLO. The details on the activities of Chunav Pathshala may be seen at 4.3. in the Project Document.

3.2.4. Voter Awareness Forums (VAFs)

Voter Awareness Forums will operate in Government Departments, Non government Organizations, Corporate and other Institutions. The membership will be open to all employees. Head of the Organization shall appoint one person as the Nodal Officer. Preference shall be given to an officer who has experience of the election duty. Nodal officer will liaise with the District Election Officer or the CEO of the State for VAF Resources. The details on the activities of VAFs may be seen at 4.3. in the Project Document.

3.3. General Features of the ELC Programme

- i) All ELCs will be given code numbers by the CEO's office and the information will reflect the membership strength.
- ECI shall provide the resources for ELC to the CEO and DEO Office for onward distribution. The same shall be available on a dedicated ECI portal specifically developed for the purpose. The Resources will be developed by the ECI in Hindi and English. The CEOs office shall get them translated in local languages as may be necessary.
- be trained by ECI. CEOs shall be responsible for planning training at state level and DEOs at district level.
- iv) Non Partisan nature of the ELCs/VAF must be maintained and the Nodal Officer shall ensure compliance of this norm.

v) Incentives shall be devised to reward and recognize well performing ELCs nd the incentives may be state or region specific to encourage the ELC members and nodal persons.

4. Student Teacher Resources & Capacity Building

- **4.1. Student Teacher Resources** for ELCs are being developed. The Resources shall be made available to the CEO's office in soft copies. CEO will process the same for adaptation and translation in the local language. Only the EL resources prescribed by the ECI shall be used as resources. Activity and resource development outside ECI must be approved by the ECI through respective CEO.
- **4.2. Training of Teachers/Nodal Officers** on the ELC resources and tools shall be an integral part of the ELC project. Master trainers for States/UTs will be trained through the IIIDEM framework. Training shall be organized at the State level and cascade down to District level in coordination with State Education Departments and other institutions. District Master Trainers shall be trained at State level/RIDEM. CEOs will devise a training calendar for the same.

5. Institutional Support

The National Electoral Literacy Committee shall be supervising the roll out of the programme at national level. Budgetary support to the tune of Rs 20 crore has been sought in the next FY for the first phase of establishment of 2 lakh ELCs across the country. CEOs may assess their fund requirements during the roll out of the project and communicate to ECI so that additional budgetary requirements can be reflected in the RE.

- **5.1. State Committee on Electoral Literacy (SCEL)** under the CEO shall be constituted in each State/UT to supervise the planning, implementation, monitoring and evaluation of the Programme within the state. Where the Committees have already been set up under the directions of the Commission for mainstreaming of the Electoral Literacy, such committees will automatically function as SCEL and the members may be added in the light of model composition as mentioned in the Project document in para 9.
- **5.2.** Similarly **District Committee on Electoral Literacy (DCEL)** shall be set up under the DEO to supervise the planning, implementation, monitoring and evaluation of the Programme within the district. The composition and role of the DCEL is detailed out in the Project document in para 10.

6. Budgetary Support

Budgetary support to the tune of Rs 20 Crore has been sought in the next FY for the first phase of setting up of 2 Lakh ELCs across the country. CEOs may seek budgetary support for the same from the State Government. Any additional fund requirements may be further assessed during the roll out of the project and communicated to ECI so that additional budgetary requirements can be reflected in the RE.

- **7. Partnerships** shall be developed at different levels for operationalisation of the ELCs. Overall framework for partnerships may be maintained at the standard guidelines and framework laid down by the Commission.
- 8. **Immediate Tasks & Timelines** The Project Document details out all aspects of the ELC programme. Meanwhile the immediate tasks are as follows:
 - i) Constitution of the SCEL and DCEL and its first meeting to chalk out course of action.
 - ii) Identification of educational institutions and nodal persons in each institution in the district and coordination for setting up of ELCs.
 - iii) Preparation of data base of ELC/VAF, Nodal persons in each ELC/VAF and number of students/members therein respectively by the district as per the **prescribed proforma**. (enclosed)
 - iv) Identification of Master Trainers at District and State level. Names of State level Master Trainers may be shared with ECI by 30th November 2017.
 - v) Drawing up the Training Calendar of Master Trainers/Nodal Persons and accordingly setting timelines for districts to nominate the District level Master Trainers.

The Timelines for the important tasks are given in annexure. ECI shall meanwhile develop and share the Student-Teachers Resources within a month.
