- (iii) Ask for any Income Certificate from the parents/applicants who have been selected under DG category.
- (iv) Ask for the relevant documents duly attested by a Gazetted Officer.
- (v) Refuse admission to the children on the ground of distance range.
- (vi) To ask the name of the child in the BPL/AAY/Food Security Card when the same is produced for claiming EWS category benefit.
- (vii) To charge/demand school fee.
- (viii) Deny admissions of the child on the pretext of minor spelling errors.

02. To Do: -

- (i) Place an enlarged printout of the list of students outside the school gates for the information and ease of parents.
- (ii) To setup help desk to facilitate the parents
- (iii) Issue acknowledgement slip to all reporting parents.
- (iv) To deal/entertain the parents politely and sympathetically.

The Department is going to constitute teams (district-wise) to conduct inspection of the private unaided recognized schools for ensuring the admission of EWS/DG category candidates shortlisted by the Department in accordance with the instructions/directions issued.

Director's Nominee will also be assigned the task to verify the admission status of EWS/DG Category candidates viz-a-viz the admission under open seats and submit the report of the admission on the department module designed by the department shortly.

In order to facilitate the parents of EWS/DG Category children in depositing necessary documents and securing admissions, the last date of granting admission is hereby extended $\underline{\text{till}}$ $\underline{16/04/2018}$.
