CIRCULAR

Sub: Prevention and Control of Vector Borne Diseases (Dengue, Chikungunya and Malaria etc.).

In continuation of circulars No.DE.23(386)/Sch.Br./2018/649 dated 01.05.2018, DE.23 (386)/Sch.Br./2017/669 dated 08.05.2018 and DE.23 (386)/Sch.Br./2018/1049 dated 17.07.2018 on the subject cited above, all Heads of Govt., Govt. Aided & Unaided Recognized Schools are directed to follow the given below action plan for control of Vector Borne Diseases:-

- Designate a Nodal teacher/person in each school/office under jurisdiction, who would be responsible for all the activities related to prevention and control of vector borne diseases and monitor the activities being carried out.
- Sensitization and awareness of students during morning assembly regarding prevention and control of dengue and other mosquito borne diseases and this activity should be continue throughout the year during assembly and PTMs.
- Awareness among school students by means of Nukkad natak, Rallies, drawing competitions, dengue related projects, Assembly talks, Dengue home work cards etc.
- Students should be given innovative projects and assignments related to dengue control during summer vacation.
- Film made by Department of Health and DIP for awareness of school students, may be played in schools.
- Head boys and head girls from senior classes may also depute to supervise the team of 10 to 15 students who will check the premises and surrounding of schools.
- Students should advise to wear clothes that cover arms and legs like full sleeves shirts, full pants/pajama and socks. They should not be allowed to play in shorts and half sleeved clothes.
- Use of mosquito repellent creams/oils to prevent mosquito bite on exposed body parts during peak season..
- Removal of stagnant water in and around school premises and special attention to be given to swimming pools.
- Overhead tanks/Cemented tanks should have well fitted lid and lid should be kept locked. Water outlet/air bent pipe of OHT should be covered with a metallic/plastic net of sufficient size to prevent entry of mosquito or covered with cloth.
- The water contained in money plant/bamboo plant kept as show piece in the official areas should be changed at least once a week after scrub cleaning and check for Aedes breeding.

- Observance of dry day once in a week in all schools (preferably on last working day) during which coolers, flower pots, bird pots, water containers, any scrap, stagnant water and other possible breeding sites to be checked thoroughly for ensuring no possibility of mosquito breeding.
- Condemned items lying in open and solid waste must be disposed off regularly and properly so that no breeding takes place. Do not let broken earthen wares, plastic container, bucket, gallons, disposable cups, bottles, coconut shells, pots etc. in open.

Further, the following officers of Directorate of Education are hereby nominated as nodal officers to monitor the Vector Borne diseases of their respective zones with the help of cluster incharges. All DDEs (District) will also depute one Nodal Officer for their district office to carry out activities related to vector borne diseases control in their respective office premises and also monitor the activities being carried out for the same. DDE (CTB) may also depute one Nodal Officer for HQ premises. The name and contact details of the below mentioned zonal Nodal Officers must be displayed on a board at some prominent place in Zonal & District Offices. HOS of all the schools will display the details of school level Nodal Officer as well as Zonal Nodal Officer.
