**CIRCULAR**

**Sub: - National Mass Deworming Programme on 10<sup>th</sup> August 2018 followed by Mop up Day (MUD) for left out children on 17<sup>th</sup> August 2018 .**

The first phase of National Deworming Programme was successfully implemented in Delhi on 10<sup>th</sup> Feb, 2018. However, since Delhi has STH (Soil Transmitted Helminthes) prevalence of 28%, therefore as per directions of Child Health Division, MoHFW, Govt. of India, henceforth with 'Two Phases of Deworming Programme shall be executed in Delhi each year, the first on National Deworming Day i.e. 10<sup>th</sup> Feb and the 2<sup>nd</sup> Phase on 10<sup>th</sup> August.

**Accordingly, it has been planned to implement the 2<sup>nd</sup> phase of School based biannual National Mass Deworming in Delhi on 10<sup>th</sup> August 2018 followed by Mop up Day (MUD) for left out children on 17<sup>th</sup> August 2018.**

All school going children in the age group of 2 years – 19 years (Nursery to class XII) will be administered a single dose of Chewable Tablet Albendazole to all age groups. Even small children, is national policy.

All schools have to nominate a nodal teacher for execution of programme in the school. The nodal teachers shall be re-trained by District MOI/Cs on administration of the chewable Albendazole tablet and reporting of the programme. Nodal Teacher will impart training to class teachers on administration of Albendazole.

However in very rare cases children with mild adverse event (pain abdomen, nausea, vomiting etc) may require medical intervention, Health & FW Department has created a three tier Emergency Response System on NDD & MUD as under (i) one ANM/PHN over 4-5 schools (ii) one MO at each Zone of Education Department (iii) One District MOI/C at District Level (iv) Control Room at SHS (HQ).
