**CIRCULAR**

The Govt. of India has started new scheme namely Samagra Shiksha from the year 2018-19. Under this scheme, Inclusive Education of Children with Disabilities for Pre-school to Higher Secondary classes has been devised. To implement the Inclusive Education in its true spirit, the Heads of all schools of MCDs, NDMC, DCB and Heads of schools aided by these local bodies are required to submit the data of Children with Disabilities studying in Pre-school (including KG & Nursery) to Class XII in the prescribed format given in **Annexure-A**. The said data is required for payment of financial assistance to these children, as per eligibility, through Direct Benefit Transfer (DBT) directly to their bank account as well as for the implementation of other interventions under Inclusive Education of Samagra Shiksha. The HOS shall submit the data in prescribed format in certified hardcopy and in softcopy (in MS-EXCEL) to the concerned DURCC by **26/10/2018**.

Further, DURCCs shall compile the data (in MS EXCEL), separately for MCDs, NDMC, DCB and their Aided Schools, as per the Proforma in Annexure - A and submit to this office within one week after submission of data by HOS. **Due care must be taken to ensure the authenticity and accuracy of data at all levels.**
