Sub. Pre-Matric, Post-Matric and Merit-Cum-Means based Scholarship Schemes under Ministry of Minority Affairs, Govt of India on National Scholarship Portal (NSP) for the year 2018-19

Principal Secretary, DSCST had convened a meeting of the State Level Project Management Committee on 11.10.2018 to discuss the matter regarding scholarship schemes on the subject noted above and further directed that HOSs of Government / Government Aided and Private Schools, should get themselves registered (if not done earlier) on National Scholarship Portal (NSP) and take appropriate action as per schedule given below :-

Despite of various circulars issued from time to time, 7277 applications as on 11.10.2018 are still pending at School / institute level which are to be verified immediately. All clarification / queries can be sorted out vide email address of Department of SC/ST/OBC/Minority Welfare Department, Govt of NCT of Delhi scstscholarship.delhi@gov.in . Further all concerned HOSs are directed to give enough publicity to the above schemes by placing the information on the Notice Board, making announcement during the morning school assembly etc to enlighten the students, so that eligible among them can apply (Fresh/Renewal) as per above dates mentioned above. - **Two level verification of applications:**
 - Verification by institute/District level for Pre-Matric Scholarship – **31/10/2018**- No extension will be given by the Ministry of Minority Affairs.
 - Verification by institute/District level for Post Matric and Merit-Cum-Means Scholarship - **15/11/2018** - No extension will be given by the Ministry of Minority Affairs.
- **District Committees have been constituted in all districts.**
- **To organize meeting of District Committees and send minutes to DSCST.**
- **Login ID and Password :-** Scheme wise ID and Password will be sent through SMS on the mobile No. of the Nodal officers/ADMs (if not sent earlier)
- **There are three options for verification-**
 - Verify
 - Reject
 - Defect - To call additional information
- **Status will be sent through system generated SMS (Text Message) to applicant's registered mobile no.**
- **In case of incorrect district mentioned by the applicant,** application may be defected by district nodal officer with the remarks of incorrect district. The application will be available at student level for correction in district, thereafter may be routed correctly.
- Defect facility is available till 31/10/18 for Pre-Matric and 15.11.2018 for Post Matric and Merit-Cum-Means.
- Bulk verification facility is also available at district level.
- As per Cabinet Secretariat decision 15.07.2017 for scholarship amount less than Rs. 50,000/-, supporting documents **to be kept at institute level** and for scholarships amount more than Rs. 50000/- should be uploaded on the portal, by the applicant.
