Sub: -Timely verification of applications under (MoMa) scholarship schemes by concerned educational institutes and District Nodal Officer of district on National Scholarship Portal (NSP 2.0)

Ministry of Minority Affairs, Govt. of India has opened the National Scholarship Portal (NSP) for verification of online application in r/o scholarship of 2018-19 under three scholarship schemes viz Pre-Matric, Post-Matric and Merit-Cum-Means for minority students as per the timelines activities are as under:-

- (i) The last date for verification by institutes level upto **15.11.2018**.
- (ii) The last date for verification by (Revenue) District level upto **15.11.2018**.

It has been noticed that despite several reminders issued from time to time, very less number of applications (details enclosed) have been verified at school level so far under the above schemes.

It is therefore directed to all concerned HOSs of Govt. / Govt. Aided / Pvt. Schools running under DoE to speed up the verification process lying pending in their school on NSP Portal and complete the verifications for all applications as per the timeline mentioned above without fail.
