At the outset, we thank all the States/UTs for their active participation in promoting Digital Payments. It is due to the combined efforts of all concerned, we have achieved 2057 errore Digital Transactions for FY 17-18. (Link-DigiPay dashboard www.digipay.gov.in).

- 2. For the next year (FY 2018-19), fresh targets for all States/UTs have been worked out and are at **Annexure I**.
- 3. A list of activities which may be considered and incorporated in all organisations concerned with your State/ UT for promotion of Digital payments is at **Annexure I(a)**. Further, details of various modes of payment which can be used to make and receive payment digitally are at **Annexure I(b)**. It may also be noted that Cheque and Demand drafts are not considered as digital payments.
- 4. Meity has initiated four incentive schemes for promotion of digital payments namely BHIM Cashback scheme for individuals, BHIM Incentive scheme for merchants, BHIM Aadhaar Merchant Incentive scheme and MDR waiver for Debit Card/ BHIM-UPI/ Aadhaar Pay transactions less than or equal to Rs. 2000/- in value.
