Subject: Payment of special increment under Family Welfare Programme

The undersigned is directed to refer to Department of Defence production's ID No. DDP-E0024/27/2018 dated 22.03.2018 on the subject cited above.

- 2. In this regard, it is informed that DPE guidelines issued vide O.M. No. BPE/GL-006/80/5(8)/80-BPE (GMI) dated 28.08.1980, 5(8)/80-BPE(GMI) dated 01.09.1981 and 5(8)/80-BPE(WC) dated 07.08.1986 have been deleted / cancelled vide DPE O.M. No. 20(10)/99-GM-GL-42 dated 27.09.2002. Further, Department of Expenditure vide its OM No. 12(4)/2016-EIII.A dated 07.07.2017 has also discontinued the Family Planning Allowance for adoption of small family norms for Central Government Employees which has already been extended to the CPSEs following CDA pattern of pay scales vide O.M. No. W-02/0058/2016-DPE(WC)-GL-XIII/18 dated 21.05.2018 (available on DPE's website i.e. www.dpe.gov.in).
- 3. Also, DPE in its O.Ms. dated 03.08.2017, 04.08.2017 and 07.09.2017, issued for 2017 pay revision of CPSE employees following IDA pattern of pay scales, has mentioned the allowances to be kept outside the ceiling of 35% of Basic Pay which does not include Family Planning Allowance for adoption of small family norms. However, the CPSEs may consider to give Family Planning Allowance for adoption of small family norms within 35% of Basic Pay (BP) under Cafeteria Approach.
