NOTICE

The Food & Supply Department intends to issue 01 (One ) temporary license for running Fair Price Shop one in each area i.e. "Vasant Enclace, Vasant Vihar", under Circle -44 (R.K.Puram) , Sec-8/938 R. K. Puram, New Delhi , as per the following guidelines:-

1. Temporary license shall be valid only for a period of 03 months from the date of issue and shall not be renewed.
2. Eligibility for grant of temporary license: the eligibility criteria for grant of temporary license including age and educational qualification shall be same as that for regular license. However, in case of dimensions of the shop, relaxation may be granted by the Competent Authority depending upon the number of ration cards proposed to be attached to the proposed temporary FPS.
3. Temporary licence shall be granted only to a person who resides in the same Revenue District in which the FPS is proposed to be located.
4. While granting temporary licence, old KOD licensee, persons belonging to SC/ST, women self help group, Ex - Service men and handicapped persons shall be given preference. As it is purely a temporary and emergent measure, reservations will not apply.
5. A person who has been convicted of an offence under the Essential Commodities Act- 1955 or any other offence under the Indian Penal Code or any other Law in enforcement in India, shall not be granted temporary licence.
6. The premises of the applicant shall be inspected by concerned FSO/FSI who will submit report to the Asstt. Commissioner concerned.
7. Based on the eligibility of the applicant, preferential category and the location of the premises, the Asstt. Commissioner will take decision for grant of temporary licence to persons/group.
8. Grant of temporary licence shall not in any way entitle the licensee to get a regular licence. For grant of regular licence, the prescribed procedure shall be followed. One person/self help group shall not be given more than one licence.
9. The application shall be submitted in the prescribed format, along with the declaration attached as annexure to these guidelines.
10. Following document shall be submitted alongwith application for temporary licence:

- a. Proof of identity.
- b. Proof of Residence.
- c. Proof of Educational Qualification.
- d. Document of ownership of proposed business premises.
- e. Copy of Passbook/ Bank Statement.
- f. Draft of security money of Rs. 10,000/- per FPS.

The last date for submission of application form in the Circle Office is upto 22.09.18 at 5:00 PM.
