It is brought to your notice that as per Sub Rule (4) of Rule 9 of CCS (Pension) Rules, 1972 in the case of Government servant who has retired on attaining the age of superannuation or otherwise and against whom any departmental or judicial proceedings are instituted or where departmental proceedings are continued under sub-rule (2), a provision pension as provided in Rule 69 shall be sanctioned.

In sub-rule (6) of Rule 9 has further been laid down that for the purpose of this rule,

- (a) Departmental proceedings shall be deemed to be instituted on the date on which the statement of charges is issued to the Government servant or pensioner, or if the Government servant has been placed under suspension from an earlier date, on such; and
- (b) Judicial proceedings shall be deemed to be instituted -
 - (i) In the case of criminal proceedings, on the date on which the complaint or report of a Police Officer, or which the Magistrate takes cognizance, is made, and
 - (ii) In the case of civil proceedings, on the date the plaint is presented in the Court.

The administrative department while forwarding the cases for authorization of pensionary benefits in respect of officers holding the post above gazetted officers are attaching the vigilance clearance issued by your Directorate where facts of pending complaints etc. and reference of OM dated 29-09-2017, 08-11-2017 of the Govt. of India is given which without further consideration are sent along with the pension cases to PAOs for interpretation and releasing of final pensionary benefits (copy of such vigilance clearance enclosed).
