CIRCULAR


Sub : Releasing of payments in respect of Contractual Workers/Outsourced agencies.

PAOs to refer to the instructions given from time to time regarding timely releasing of payments in respect of contractual/outsourced agencies against the bills of DDOs of various departments of the Government to comply with the instructions of the Government for payments to such workers/agencies before 7th of each month.

An incident of delay in crediting the payments in the bank accounts of contractual workers has been reported by a department of the government which had happened as PAO concerned had not taken timely action for obtaining the electronic payment instructions from the DDOs which initially were returned by the bank due to technical error. The delay could have been avoided if PAO had personally monitored the matter and obtained revised details from the DDO and in case of technical problem would have consulted the Technical Team of Principal Accounts Office.

It is therefore, again advised that PAOs would personally monitored the timely arrangement of payments in respect of contractual workers/outsourced agencies any lapse on this account would be the personal responsibility of the PAO concerned and appropriate action would be taken against the defaulting officer/official

This issue with the approval of the Controller of Accounts.
