


OFFICE MEMORANDUM

Sub: Extension of the Hon'ble Supreme Court of India order, dated 01.09.2017 in SLP Diary No.23663/2017 -Govt of NCT of Delhi and another vs Somvir Rana and others to applicants/petitioners in various cases.

The undersigned is directed to refer to D.O. letter No.CC/WPC-8922/2017/LIT/2018/8046, dated April 05, 2018 from Chief Secretary, Government of NCT of Delhi to Secretary(Expenditure) regarding compliance of the order, dated 01.09.2017 in SLP Diary No.23663/2017 of the Hon'ble Supreme Court of India by issuing appropriate orders for grant of pay scales to Teachers promoted as Trained Graduate Teachers (TGT) on or after 01.01.2006.

2. This Department agrees to the proposal as contained in the letter, dated 05.04.2018 of Chief Secretary, GNCTD, to allow the benefit of the order, dated 01.09.2017 of the Supreme Court to all those TGTs who were appointed as such prior to or subsequent to 01.01.2006 and their pay may be re-fixed at the level of Entry Pay applicable to TGTs appointed as DRs on or after 01.01.2006. The re-fixation of pay would take place on 01.01.2006 or the date of appointment as TGT, whichever is later. The financial implication on account of re-fixation of pay will be borne by the GNCTD.


