If in any case expenditure sanction of the competent authority is not submitted with the payment bill by the DDO of the Department, the same may be brought to the notice of the undersigned immediately for appropriate action.

Governor. These have also not been issued in the manner specified under Section 44(2) GNCTD Act and have not been authenticated in the manner provided under Section 44(3) of the said Act read with Authentication of Orders and Other Instruments (Amendment) Rules, 1992, as amended up-to-date.

Therefore, Hon'ble Lt. Governor has desired that Chief Secretary may kindly draw attention of all concerned including Pay & Accounts officers towards the fact that the aforesaid orders dated 29.11.2017 and 18.01.2018 have not been validly issued in view of the material infirmities noted above.

Section 44 (2) and 44(3) of the Government of NCT of Delhi Act, 1991 are as follows:

"44. Conduct of business:

- (2) Save as otherwise provided in this Act, all executive action of Lieutenant Governor whether taken on the advice of his Ministers or otherwise shall be expressed to be taken in the name of the Lieutenant Governor.
- (3) Orders and other instruments made and executed in the name of the Lieutenant Governor shall be authenticated in such manner as may be specified in rules to be made by the Lieutenant Governor and the validity of an order or instrument which is so authenticated shall not be called in question on the ground that it is not an order or instrument made or sexecuted by the Lieutenant Governor."
- 2. To have legal validity, all executive decisions have to be taken by the authority competent to take such decisions, and orders issued in pursuance thereof have to be authenticated by an officer authorised to do so under the Government of NCT of Delhi (Authentication of Orders and other Instruments) (Amendment) Rules, 1992 as amended in the year 2000 (copy enclosed).
- 3. Recently, some instances have come to notice, where orders have been issued under the signature of officers/ authorities, other than the authorised officers, in violation of the provisions of section 44(3) of the Government of NCT of Delhi Act, 1991 read with the aforesaid rules.
- 4. Hon'ble Lt. Governor has therefore desired that the Chief Secretary may kindly draw attention of all Secretaries to Ministers / Principal Secretaries / Secretaries / Head of Departments of GNCTD to the aforesaid provisions of the Government of NCT of Delhi Act, 1991 and the Rules made thereunder for strict compliance.
- 5. Any officer, who disregards the above provisions of law / rules shall do so at his own risk and will be liable for appropriate action by the competent authority, including disciplinary proceedings and recovery of financial loss to the Government exchequer, as a result of his/her actions.
- 6. This issues with the approval of Hon'ble Lt. Governor.
