





**OFFICE MEMORANDUM**

Subject:- Revision of rates of Operation Theatre allowance (Special allowance) to the Nursing Personnel working in Central Government Hospitals as per recommendations of the 7<sup>th</sup> CPC - regarding

Consequent upon the decision taken by the Government of India on the recommendations of the 7<sup>th</sup> Pay Commission, the President is pleased to revise the rate of Operation Theatre allowance (Special allowance renamed as Operation Theatre allowance) from Rs.360/-per month to Rs.540/- per month to the Nursing Personnel working in the following specialized areas in Central Government Hospitals/ Institutions under the Ministry of Health & Family Welfare :-

- Humayun*  
*7/11/17*  
*S.O (Med)*
- All Major Operation Theatres
  - All Intensive Care Units/ Intensive Care Treatment areas
  - Coronary Care Units/ Cardiac Catheterization Laboratories
  - Dialysis Unit/ Ward and Transplant Units/ Wards
  - Intensive Care Units for Burns
  - Tetanus Wards and Rabies Wards
  - Paediatric Nursery/ Neonatal Units

Operation Theatre allowance admissible to nursing personnel is subject to the following conditions:

- For SPT*  
*AAJ*  
*10/11/17*
- The allowance shall be paid to the nursing personnel for such period only when the concerned staff is actually working in the specified areas. The minimum period for working in the specialized areas will be two to three years.
  - No Nursing Officer with less than one year of service is to be posted for duty in these areas.
  - This allowance is restricted to 35% of the total staff strength of nursing staff of any hospital/ Institution.

3. The revised rates of allowances shall be admissible with effect from the 1<sup>st</sup> of July, 2017.

4. This issues with the approval of Deptt of Expenditure vide ID No.A.27023/1/2017/E.II.B(7th CPC)/Pt. dated 14.09.2017.



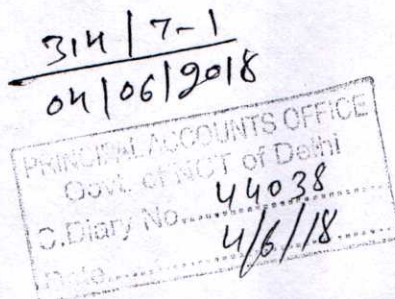

Office Memorandum

Sub:- Revision of provisional pension sanctioned under Rule 69 of the CCS (Pension) Rules, 1972

The undersigned is directed to say that in implementation of the decision taken on the recommendations of the 7<sup>th</sup> CPC, orders were issued vide this Department's OM No. 38/37/2016-P&PW(A)(ii) dated 04.08.2016 for revision of pension of pre-2016 pensioners/family pensioners w.e.f. 01.01.2016 by multiplying the pre-revised pension/family pension by a factor of 2.57. Subsequently, vide OM No. 38/37/2016-P&PW(A) dated 12.05.2017, it has been decided that the pension/family pension of all Central civil pensioners/family pensioners, who retired/died prior to 01.01.2016, may be revised w.e.f. 01.01.2016 by notionally fixing their pay in the pay matrix recommended by the 7<sup>th</sup> CPC in the level corresponding to the pay in the pay scale/pay band and grade pay at which they retired/died.

2. Instructions were issued vide this Department's OM of even number dated 30.11.2016 for extending the benefit of OM dated 4.8.2016 to the following categories of pensioners drawing provisional pension under Rule-69 of the CCS (Pension) Rules, 1972.

- (i) Retired before 1.1.2016 and sanctioned provisional pension under Rule-69 of the CCS (Pension) Rules on account of departmental/judicial proceedings or suspension.
- (ii) Suspended before 1.1.2016 and sanctioned provisional pension, based on their pre-revised pay under Rule-69 of the CCS (Pension) Rules on retirement on or after 1.1.2016.

3. It has now been decided that provisional pension sanctioned in the above cases may be revised w.e.f. 1.1.2016 in accordance with the instructions contained in this Department's OM No. 38/37/2016-P&PW(A) dated 12<sup>th</sup> May, 2017. Higher of the two formulations i.e. OM dated 4.8.2016 or OM dated 12.5.2017 would be the revised provisional pension w.e.f. 1.1.2016 in such cases.

4. This issues with the approval of Department of Expenditure, Ministry of Finance ID No.1(21)/E-V/2016 dated 15.01.2018.
