Sub : Observations on the Pension Payment Orders.

Sir,

It is to inform you that in the recent meeting of PAOs of this Organization it has been intimated by the PAOs that PPOs sent by their offices are returned by your office putting petty observation which is delaying the payment of pensions to the pensioners/family pensioners.

The observations as raised by your office in certain cases are as Under :-

- i) Where pension is authorized to the eligible children by issuing fresh PPO a certificate is being insisting upon to the effect that existing PPO issued in favour of the pensioners/family pensioners has been cancelled.
- ii) Certificate to the effect that payment of additional amount of DCRG, Commutation of pension has not been paid through Head of Office in those cases where payment of pension through Bank has already been commenced.
- iii) Stamp of PAO affixed on the photograph of the pensioner is either dark or on the upper area of the photograph of the pensioner/family pensioner.

In this context it is relevant to inform that the pension to the eligible child can only be authorized through fresh PPO after cancellation of PPO issued to the pensioners received back from the Bank through your office. Hence insisting upon a separate certificate in this regard would not be justified.

Further as per the provisions of Pension Rules and also COMPACT software the additional amount of DCRG and commutation of pension becoming payable on revision of pension as from the date of retirement, would be payable through the Bank from where the pension is being drawn. Therefore, the authorities issued by PAOs for payment of additional amount of DCRG or commutation of pension may be accepted without insisting upon a separate certificate.

In view of the above it is requested to issue necessary instructions to the concerned Officers to your office to accept the PPOs as per authorization made in the PPO/revised authority without insisting upon separate certificate. The PAOs are also being advised to ensure the submission of complete cases to your office to avoid the needless observations and returning of PPOs.


