All the Universities and Colleges under the control of Department of Training & Technical Education are hereby requested to revise the pension and family pension of faculty and other staff retired before 2006 immediately.

Further, it is advised that if the University/College has fixed the pension in a manner different from the above formulation, the same may have to be reworked by the concerned University/ college and necessary adjustment made. It may be pointed out that only those pre-2006 pensioners would be eligible for full pension who have rendered not less than 33 years of qualified service
