CIRCULAR

Following terms and conditions are framed within the ambit of section 20 of the Delhi Excise Act, 2009, for allowing the transfer of licence in the case of restaurant (L-17/L-17F, L-18/L-18F,L-19/L-19F):-

- 1. Proceedings of any kind under the Delhi Excise Act, 2009, and rules framed thereunder, or under the erstwhile Punjab Excise Act, 1914, and rules framed thereunder, should not be pending against the licensee before any such approval is allowed.
- 2. The transferee will run the restaurant/bar in the same premises.
- 3. Prior approval of Licensing Authority should be sought within the purview of section 20 of the Delhi Excise Act, 2009.
- 4. An affidavit will be submitted by the transferor and transferee (separately), along with the application for obtaining permission for transfer of licence, in the prescribed format. (Annexure 'A' & 'B').
- 5. Licensing Authority may permit the transfer of license subject to payment of 25% of annual licence fee for the restaurant in question.
- 6. No refund for licence fee will be allowed to the transferor-licensee for any unexpired period of financial year.
- 7. Transferee will submit all licenses/NOCs from link departments viz. Health & Trade Licence, Eating House Licence, NOC form DFS and Approval of DOT, along with PAN Card and DVAT registration certificate in the name of transferee, within a period of three months or the validity of the licence, whichever is earlier.

8. Permission for transfer on compliance of above terms and conditions will be allowed only if transfer has happened after coming into force for Delhi Excise Act, 2009 i.e. after 04.10.2010.
