Sub: **Conferment of powers by 'virtue of office rather than on individual officers by name'.**

It has been observed by the Hon'ble Lt. Governor that the practice to confer powers by 'virtue of office rather than on individual officers by name' should be adopted in all Government of NCT of Delhi, if legally permissible. This would obviate the need of submission of files for conferment of power in case of transfer and posting. Copy of U.O. No. 6(1)/18-RN/173/A-2077 dated 24.04.2018 received from Pr. Secretary to Lt. Governor is enclosed.

In a file received from Department of Weights & Measures, GNCTD, the proposal of the department, as vetted by Law Department for conferment of powers of LMOs on the post of Controller/ Assistant Controller/ Inspector under Legal Metrology Act, 2009 by 'virtue of office' was approved by the Hon'ble Lt. Governor.
