

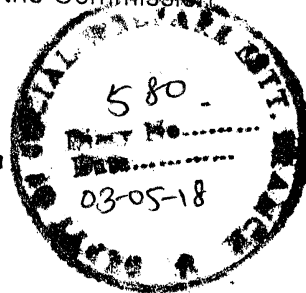

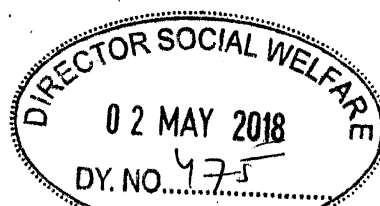

The expenditure involved will be met out of the grants-in-aid of the Commission under the head A-3 Professional and other services.

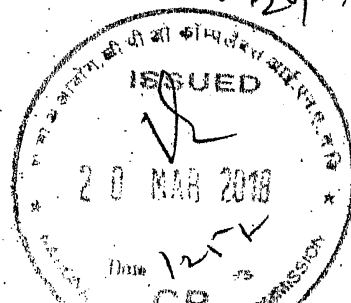

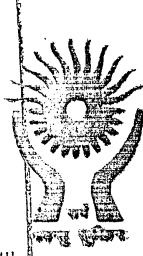
