Sub: Revision of pension of pre-2016 retirees of Govt. of NCT of Delhi to PAOs.

Sir/Madam,

It is brought to the notice that as per the instructions on the revision of pension of pre-2016 pensioners/family pensioners the complete cases of revision of pension are required to be submit to PAOs by the Head of Offices after notional fixation of pay of the pensioners/family pensioners in the Pay Matrix recommended by the 7th CPC in the level corresponding to the pay in the Pay Scale/Pay Band at which they retired/died. The said notional pay would be done under each intervening Pay Commissioner based on the formula of revision of pay.

In order to ensure the timely revision of pension in respect of pre-2016 pensioners/family pensioners of Govt. of NCT of Delhi it was requested vide this office letter dated 29-06-2017 followed by reminder dated 22-11-2017 to issue instructions to all the Heads of Offices under your control to arrange the submission of revision of pension cases to PAOs to enable them to sent the revised Pension Authorities to the Office of CPAO, Ministry of Finance, Govt. of India, Bhikaji Cama Place, New Delhi.

The Chief Controller (Pensions), Office of CPAO, Ministry of Finance, Govt. of India 17-04-2018 addressed to the Secretary (Finance), Govt. of NCT vide his DO letter dated of Delhi has intimated that in 54185 pension cases in respect of pensioners/family pensioners of Govt. of NCT of Delhi pension is still to be revised and further advised to take immediate steps for revision of pension in pending cases.

It is therefore again requested to issue necessary instructions to all the Heads of Offices under your control to review the outstanding cases of revision of pensions/family pensions in respect of pre-2016 and arrange their submission to concerned PAOs on priority basis. It is also requested to designate an Officer of appropriate level in your department to monitor the progress on the revision of pensions/family pensions and send a fortnightly report to this office.
