

MEETING NOTICE

Action for processing the pension cases is to be taken by the HOOs and complete case would be sent to PAO concerned for authorization.

As per the present status out of 57923 pensioner/family pensioners of the Govt. of NCT of Delhi pension in 24573 cases have been revised and 33350 cases are pending for sanction/authorization.

The Govt. of India, Ministry of Finance in Review Meeting has advised to ensure the finalization of remaining case of Govt. of NCT of Delhi in a time bound manner. Accordingly, a meeting has been fixed under the Chairmanship of the Special Secretary, Finance Department, Govt. of NCT of Delhi in the Conference Hall of Principal Accounts Office, Govt. of NCT of Delhi at A-Block, Vikas Bhawan, I.P. Estate, New Delhi on 18-07-2018 at 03:00 PM to review the pending cases pertaining to your departments.
