Sub: Revision of pension of pending cases of Pre-2016 pensioners/family pensioners.

Sir,

This is with reference to the meeting held on 18/07/2018 under Chairmanship of Spl. Secretary (Finance) to review the status of pending cases of revision of pension of Pre-2016 pensioners/family pensioners wherein it has been advised to ensure the finalization of remaining case in a time bound manner.

Accordingly, a meeting of All DDOs/HOOs, Deptt. of Social Welfare was convened on 26.07.2018 at 02.30 p.m. to discuss the status of pending cases of revision of pension of Pre-2016 pensioners/family pensioners and in the meeting, some measures were discussed which are to be followed for earlier revision of pension as follows:

- a) Pension case files and the Service Book will be the documents for verification of Pay Scale, Last Pay Drawn and Post held by the pensioner at the time of retirement/death
- b) Fitment table for fixation of notional pay issued by the Ministry of Finance, Govt. of India
- c) In case of non-availability of documents at the level of Head of Office records of PBR can be consulted or records could be obtained from PAOs if available in their office
- d) In case the above said records are not available, PPO may be obtained from the pensioner/family pensioner, if their contact number is available

It is therefore advised to submit the pending cases of revision of pension of Pre-2016 to the PAO concerned and a compliance report in the prescribed proforma enclosed herewith may be submitted to the undersigned within two weeks.
