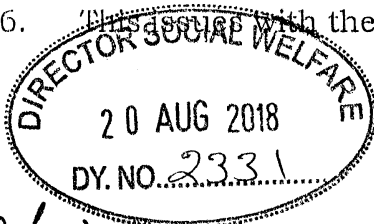

CIRCULAR

It has been brought to the notice of Services Department that a number of officers of GNCTD have preferred representations directly to the Ministry of Home Affairs, Government of India requesting therein that they may not be considered for induction into DANICS Cadre.

2. In this regard, attention is drawn to the enabling provision at para 17.12 of DOP&T's OM No. 22011/5/86-Estt(D) dated 10.04.1989 which provides for submission of a request for refusal to accept the offer of promotion, consequent upon the issuance of order of promotion. Accordingly, it is requested to advise all the eligible officers for induction to DANICS not to submit any representation for refusal of promotion directly to Ministry of Home Affairs at this stage. Further, submission of representation without following the prescribed channel is also violative of instructions contained in DoPT OM No. 11013/08/2013-Estt(A-III) dated 31.08.2015.
