Conclusion of Test Report of KRISHNA PASSENGER E-Rickshaw:- Maximum 30 minutes speed 22.3 KM/HR; Max. Power 1.9 kw & Maximum 30 minutes power 1.4 kw. It has been certified by the testing agency that the vehicle meets the requirements as per Notification G.S.R. 709(E) and the tests were conducted as per the requirements of AIS-041: 2003, S.O. 2590(E) dated 08.10.2014.									
In view of clarification received from ICAT vide letter No.ICAT/PMG/2016-17/022 dated 22.03.2017 in a similar case, E-Cart should not exceed GVW 738 Kg and Load Carrying capacity 310 Kg. under all circumstances.									

The approval is accorded subject to the responsibility of the manufacturer / Importer for ensuring the fitment of the same component, parts/ assemblies etc details of which are given in detailed specifications endorsed by the CIRT, Pune.

The manufacturer / dealer will sale E-rickshaws & E-Carts for registration in Delhi only to those persons who are in possession of an effective Learners' Driving License to drive an E-rickshaw/E-Cart issued by the Transport Department after obtaining a trade certificate in Form-17 as per the provisions of rule 35 of CMVR from the Transport Department. This approval is further subject to opening of dealership and sale through authorised dealers only.

All MLOS / MLO (HQ)/CMVI / ARU (Burari) are requested to accept the Base model KRISHNA PASSENGER and its one variant E-Cart manufactured by M/s Jain Power Corporation in NCT of Delhi subject to fulfilment of provisions of Motor Vehicle Act, 1988 and rules made there under and the department's instructions/order issued from time to time in this regard.
