

Commissioner (VIU) / (ARU/TU) shall also ensure that all the components and installation of speed limiting device type approved for particular model / variant fitted by M/s Pricol Ltd. shall be as per the technical specifications given in Type Approval Certificates and COPs and Test Report and should be as per approved layout, and in compliance of the directions of the Supreme Court Committee on Road Safety. Further, it will be ensured that the fitment of SLDs should be in accordance with the provisions of Motor Vehicles Act, 1988 and rules made thereunder including CMVR, 1989, directions of Supreme Court Committee on Road Safety, departmental notifications / instructions / orders issued from time to time for the purpose of Speed Limiting Device related to issuance of COF under section 56 of Motor Vehicles Act, 1988.

The Dy. Commissioner (VIU) / (ARU/TU) shall also ensure that the type the type approval certificates/ test reports issued by the designated testing agencies under Rule No.126 of Central Motor Vehicles Rules, 1989 are duly verified.

The Dy. Commissioner (VIU) / (ARU/TU) shall meticulously ensure to maintain proper record of the fitness certificates of Transport vehicles issued with respect to inspection of SLD as per directions of Supreme Court Committee on Road Safety letter No.F.15/2016/CoRS dated 11.04.2017 and Office Order No.SCOT/Tpt/2017/582-586 dated 29.05.2017.
