

CNC Machine Operator

The role entails setting up and base level operations of different machine tools and same can be performed manually and through automatic machines/ robots. CNC Machine Operator is often called Assistant Machinist, Junior Machinist, Lathe Operator, Apprentice Machinist, Semi-Skilled Operator. This role primarily involves supporting the machine operator in all pre-machining activities, machining of the actual part, ad hoc repair work like in auto service stations, gauging, de-burring and inspection activities

Welding Technician

The role is responsible for supporting the Welder/ mechanic in various types of joints metallic frames, jigs, fixtures, plates, sheets etc. using heating and metallic process created through electrical power and gaseous discharge.

A **Sewing Machine Operator**, also called a 'Stitcher or Machinist' is an important job-role associated with Apparel sector. The primary responsibility of a machinist is to stitch/ sew fabric, fur, or synthetic materials to produce apparels.
