

Note - 1. The age limit for direct rectx. will be relaxable in case of Schedule Caste/Schedule Tribes candidates and other special categories of persons in accordance with the General orders issued from time to time by the Central Govt.

2. Nothing in these rules shall affect reservation and other concessions required to be provided for Schedule Castes and Schedule Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. from time to time.

3. No male candidate who has more than one wife living or no female candidate who has married person already living shall be eligible for appointment in case of direct rectx. provided that the Administrator, Delhi may after being satisfied that there are special grounds for doing so, exempt any such candidate from the operation of this rule.

4. Where the administrator is of the opinion that it is necessary or expedient to do so, he may by order for reasons to be recorded in writing relax any of the provisions of these rules with respect to any person, class or category of persons/posts.
