NOTIFICATION

Subject:- Scheme for Regularization of Unauthorized Water Connections.

The Delhi Jal Board in its meeting held on 01-03-2016 vide Resolution No.266, Item No.Admn. 92 has approved re-launch of the following scheme for regularization of unauthorized domestic & commercial water connections with immediate effect :

- (a) An amount of Rs.500/- per connection for domestic category cases and Rs.1500/- for commercial/ industrial cases per connection, in place of Rs.3000/-levied as penalty in the existing policy.
 - (b) A lump sum amount of Rs. 500/- in case of domestic category and Rs. 1500/- in commercial /industrial category be levied per connection in place of water charges for three years as prescribed in the existing policy.
 - (c) The policy will be applicable on such unauthorized connections existing on the date of implementation of policy where technical feasibility exist, DJB water distribution system has been notified and subject to fulfillment of other normal conditions as prescribed in Delhi Water and Sewer (Tariff & Metering) Regulation-2012 and circulars on the subject.
 - (d) Development charges & Infrastructure charge, wherever applicable, are to be paid as per the prevalent policy of the Board.
 - (e) Applicant will be required to complete the documentary formalities as prescribed under Delhi Water and Sewer (Tariff & Metering) Regulation-2012 and circulars on the subject.
2. All applications for regularization received during the scheme or pending for sanction/payment will be eligible for benefit of above scheme.
 3. This scheme shall come into force from the date of issue of this order and shall be operational upto 18-07-2016.
 4. This issues in anticipation of the confirmation of the minutes of the meeting of the Board.
