During the said programme, the electors can verify their details in the electoral rolls like Name, Relation Name, Age, Address, Photographs etc. The electors can verify their details through:-

- o National Voters Service Portal www.nvsp.in.
- o Voter Centres of concerned Assembly Constituency (list available at www.ceodelhi.gov.in)
- o Common Service Centres (CSCs) (list will be available at www.ceodelhi.gov.in) 1950 (PwD only)

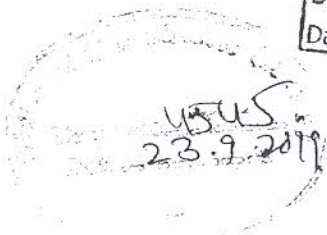
The electors will register themselves at NVSP or Voter Helpline App with the help of EPIC No., Mobile No. & Email Id and verify his/her family details and upload anyone of the documents like Aadhaar card, Passport, Driving License, Office Identity card, Bank pass book, Ration card and Farmers Identity card and then tag them together as Family.
