CIRCULAR

Subject: Online admission process for admission under EWS category from 2nd Onward against available seats in Private Unaided Recognized School of Delhi for the session 2019-20.

The Private Unaided Recognized Schools (except minority) running on the land allotted by DDA / Govt. agencies are under obligation to provide 20% seats of fresh admission under general category student beyond 2nd class onward to EWS category candidate as per condition of allotment.

In WPC No. 4607, title as "Justice for all Vs Directorate of Education, GNCTD" Hon'ble High Court of Delhi has observed that seat available under EWS category in classes from 2nd onward will be filled and department has also given consent to develop mechanism to fill vacant seats, through online admission process.

To calculate the exact number of remaining EWS category vacancies beyond 2nd onward all DDE were directed to provide the vacancy data of IInd onward of EWS for year 2018-19 and 2019-20 vide order dated 28.11.2018 .

In compliance of direction issued time to time finally vide circular dated 28.11.2018 vacancy position submitted by all DDE is complied as annexure -I by adding vacancy of 2018-19 for academic session 2019-20.

To further reconfirm the accuracy of the above mentioned vacancy data, all the concerned schools are hereby given time till 25.01.2019 to check the vacancies of EWS category of their school (as per the enclosed annexure) and in case of any discrepancy, school shall submit a written representation to the Private School Branch (earlier Act-I Branch), DoE, Old Secretariat, Delhi-54, duly forwarded by concerned District DoE within stipulated time period 25.01.2019 to 31.01.2019.


Further, it is for the information to the all concerned viz schools, parents and other community stake holders, they can also submit their representation in case of discrepancy with supportive documents to concerned DDE Districts by 31.01.2019.

If no representation is received from the concerned school, then it will be presumed that the data as per Annexure-I in respect of the school is correct and accordingly students will be allotted through computerized draw of lots. Thereafter, school shall not deny the admission to the successful candidates of the draw of lots on the ground of "No Vacancy". If any school denies the admission on this ground,



then the necessary action will be taken against the school as per the relevant provisions of DSEAR, 1973 and RTE Act, 2009. Direction in respect of Private Unaided Recognized School (minority) running on the land allotted by the DDA/Govt. agencies will be issued through separate circular.


