#### **CIRCULAR**

Dear Mr. Bhushan,

You may be aware the Department for the Welfare of SC/ST/OBC/Minorities is implementing eight types of scholarship schemes for the welfare of SC/ST/OBC/Minority students belonging to deprived sections of the society. Funds under these schemes are released on half yearly/yearly basis through DBT mode. Since 2016-17 the Department has launched all these schemes in E-portal of NIC. As per procedure students/eligible candidates are applying for scholarships through E-portal and subsequently the details of students is being verified by concerned public and/or private schools and thereafter approved by DD of concerned zone before the scholarship is released by this department into the account of beneficiary.
