Subject: Guidelines / Instructions for admission of the successful Children with Disabilities category candidates of 6th computerized draw of lots for the session 2019-20.

Directorate of Education so far conducted five round of computerized draw of lots to fill the available seats under EWS/DG/CWSN/Freeship category at the entry level classes / beyond entry level classes in Private Unaided Recognized Schools (excluding minority schools) for the session 2019-20.

In continuation 6th computerized draw of lots has also been conducted on 18/07/2019 for filling some vacant seats under Children with Disabilities category at the entry level classes in Private Unaided Recognized Schools of Delhi, among the afresh invited applications vide circular dated 28/06/2019. The result for the same can be checked on the next day on the department website i.e. www.edudel.nic.in, SMS on registered mobile of the successful candidates of the draw will also be sent.

Admission of all the successful candidates will be done in accordance with the Guidelines / Instruction issued vide circulars dated 27/02/2019 & 07/03/2019 and all successful candidates will have to approach the allotted school before 31/07/2019 (Wednesday) for admission.

CIRCULAR

Subject: Regarding instructions/guidelines for aspirants of the category of Children with Disabilities as defined in Rights of Persons with Disabilities Act 2016 (RPWD Act, 2016) to apply fresh online application against the remaining vacant seats at the entry level classes (Nursery, KG & Class-I) for the session 2019-20.

In compliance to direction of Hon'ble Court in WPC 1225/2014 and with prior approval of competent authority, Directorate of Education issued an notification dated 23.07.2018 (copy attached) regarding reservation of 3% seats from the total seats under EWS/DG category in private unaided schools of Delhi for admission of Children With Disabilities as defined in the Rights of Persons with Disabilities Act, 2016.

Despite inviting online application against the available seats vide circular dated 15/01/2019; approximately 5000 seats are still vacant, against which no online application is available.

Hence, department has decided to call fresh online applications again from the aspirants of Children With Disabilities as defined in RPWD Act, 2016 against these reserved available seats at present.

List of schools (with the available vacancies/seats for children with disabilities as defined in the RPWD Act, 2016) will be available on the departmental website www.educlel.nic.in from 04/07/2019 onwards.

For instructions/guidelines regarding eligibility for applying online for seeking admission under Children with Disabilities Category, all concerned may see the relevant provisions of the circulars dated 27/02/2019 (copy enclosed), however, in addition applicants must have disability

certificate issued from a Govt. Hospital as mentioned in assessment guidelines issued under RPWD Act, 2016.
