CIRCULAR

Subject:- Random Checking by Police Personnel around Schools at the time of change of shift / Closing of School.

The Task Force on Women Safety in Delhi has been holding meetings to ensure that the actionable measures for women safety are taken. In one of the meetings, it had been decided that Delhi Police should intensify random checking around the schools, especially at the time of change of shift / Closing of School.

2. In a meeting held recently to review the progress on various action points relating to the recommendations of the Task Force, it had been decided that all schools under the Directorate of Education must ascertain as to whether these checkings are taking place or not.

3. It has accordingly been decided that, all Heads of Govt., Govt. Aided and Recognised Aided Schools shall ascertain the presence of a police personnel / mobile police van etc around the school premises during the period of Change of Shift / Closing of School. A report in this regard regarding the presence of the police personnel/ police van, that is

- Whether a police personnel was permanently deployed at the time of change of shift? (Yes/No)
- Whether a mobile police van or police personnel took a round outside the school premises at the time of change of shift, and if so the number of times for which the round was taken during this total period of 30 minutes on 25.07.2019.

is to be submitted through the online proforma prepared for gathering this information. The above online module will be deployed as a pop-up on MIS on 25.07.2019.

All the Heads of Govt., Govt. Aided and Recognised Unaided Schools are therefore directed to provide the following information in the above mentioned online module (pop-up) on 25.07.2019 positively:

In case of Schools running in double shift, HoS of both the shifts of the school in consultation and coordination with each other shall depute 2 to 3 teachers for 15 minutes before the change of the shift and 15 minutes after change of the shift on 25.07.2019 at the gate(s) of the School.

In case of Schools running in single shift, concerned Heads of Schools shall depute 2 to 3 teachers for 15 minutes before the Closing of School and 15 minutes after closing of School on 25.07.2019 at the gate(s) of the School.
