

Sir/Madam,

Kindly refer to the D.O. letter of even number dated 05.07.2019 from Secretary (Minority Affairs) and my letter No. 8-4/2019-SS dated 17.07.2019, both addressed to Chief Secretary/Administrator of all States/UTs regarding implementation of three Scholarship Schemes of this Ministry viz. Pre-Matric, Post-Matric and Merit-cum-Means for the six notified minority communities during 2019-20 through the National Scholarship Portal (NSP). The NSP has been opened from 15.07.2019 for submission of online application in any of the three Schemes by eligible candidates. In order to avoid delay and ensure timely disbursement of Scholarship the cooperation of the States/UTs is once again solicited and the following is brought to your attention for immediate action:

- The details of State/UT Nodal Officer (Scheme-wise), as confirmed by the States/UTs, have been uploaded on the NSP. The details of the District Nodal Officer (Scheme-wise) are also to be uploaded to facilitate verification of School/Institute level Nodal Officers for 2019-20 as well as for the verification of applications where District is the second level verifying authority. **Hence the State Nodal Officer may kindly be directed to update the requisite information in respect of their District Nodal Officer, Scheme-wise immediately. In this regard a provision has been made available on NSP to verify the District Nodal Officer.**

- A copy of the advertisement issued by the State/UT may kindly be furnished. A template has already been provided by the Ministry for this purpose.
- The status of registration of Institutes, verified by the District/State Nodal Officer, as available on NSP as on 26.7.2019 is enclosed. It may be seen that the number of Institutes registered so far is very low even after 2 weeks of the opening of the Portal. The State Nodal Officers/District Nodal Officers may kindly be directed to expedite the registration of the Institutes on priority basis. Also due emphasis may be given on proper advertisement and publicity of these Schemes.
