CIRCULAR

Sub:- National Mass Deworming Programme on 08th August 2019 followed by MOP up Day (MUD) for left out children on 16th August 2019.

The first phase of National Deworming Programme was successfully implemented in February, 2019. As per direction of Child Health Division, MoHFW, Govt. of India, two phases of De-worming programme shall be executed in Delhi each year.

It has been planned to implement the 2nd phase of School based biannual National Mass De-worming programme in Delhi on 08th August 2019 followed by MOP up Day (MUD) for left out children on 16th August 2019.

All school going children from Nursery to class XII (3 to 19years), will be administered a single dose of chewable Tab. Albendazole.

One full tablet will be administered to children in the age group of 3-19 years. The tablet must be chewed and taken with safe drinking water under the supervision of trained teachers/Head of Schools. Children should not be allowed to take the medicine home.

All schools have to nominate a Nodal Teacher for execution of programme. Nodal Teacher will impart training to class teachers on administration of Albendazole.

Albendazole tablet is as such a safe drug, however in very rare cases, children with pain in abdomen, nausea vomiting etc. may require medical intervention. Health & FW Department has created a three tier Emergency Response System on National Deworming Day (NDD) & MOP up Day (MUD) as under (i) One Auxiliary Nursing Midwife (ANM)/ Public Health Nursing Officer (PHNO) over 4-5 schools (ii) One Medical Officer (MO) at each Zone of Education Department (iii) One District Medical Officer Incharge (MOI/C) at District Level (iv) Control Room at School Health Scheme (SHS) (HQ).
