CIRCULAR

Sub: Prevention and Control of Vector Borne Diseases (Dengue, Chikungunya and Malaria).

In continuation of circular No.DE.23(386)/Sch.Br./2019/270 dated 14.06.2019 on the subject cited above, all Heads of Govt., Govt. Aided & Unaided Recognized Schools are directed to follow the given below action plan for control of Vector Borne Diseases:-

- Designate a Nodal Officer/teacher in school who will monitor the implementation of all the activities related to prevention and control of vector borne diseases as directed by the department.
- Once in a week in all schools (preferably weekend) coolers, flower pots, bird pots, water containers, any scrap, stagnant water and other possible breeding sites to be checked thoroughly for ensuring no possibility of mosquito breeding.
- In order to make students, teachers and other staff aware by means of Quiz, drawing competitions, dengue related projects, Nukkad Natak, Assembly talks etc may be conducted.
- Students must be advised to come in full sleeves clothes & trousers which can prevent mosquito bite to a large extent.
- Information related to vector borne diseases is to be displayed on Notice Boards and other prominent places in the school premises.
- Designated Nodal Officer will monitor the prevention and control of vector borne diseases as per format given (enclosed as Annexure-A). Week wise vector control related activities may be recorded by Nodal Officer in the format which is to be signed by HOS.

All Heads of Govt., Govt. Aided & Unaided Recognized Schools under DoE have to send the above mentioned format & compliance to the Zonal DDEs. It must be ensured that there are no mosquitogenic conditions in any of the school.

This issues with the prior approval of Competent Authority.


