



As you are aware, the Ministry of Minority Affairs has already notified the time schedule for Pre-Matric, Post-Matric and Merit-cum-Means based Scholarship Schemes for Minorities for the year 2019-20.

A copy of the letter No.8-4/2019-SS Govt. of India, received from Ministry of Minority Affairs dated 17.07.19 is enclosed herewith.

You may fix the specific responsibility on the teachers incharge and Heads of Institutes. In this regard, it will also be useful to assign the responsibility of monitoring the process of applications forms to the concerned Senior officers of Higher Education Department in their respective jurisdiction.

Our endeavors must be to bring down the rate of rejection of application to zero and to ensure that the maximum number of eligible students benefited of the scholarships .
