No. F.27(4)/2012/Sectt.Br./Edn./1454-62.—In exercise of the Powers conferred by the proviso to article 309 of the Constitution of India, read with the Govt. of India, Ministry of Home Affair's Notification No.27/78/68-DH(S) dated 24-09-1968, the Lieutenant Governor, National Capital Territory of Delhi hereby makes rules regulating the method of recruitment to the post of Law Officer in Directorate of Education, Government of National Capital Territory of Delhi as follows namely:—

- Short title and commencement (i) These rules may be called the Directorate of Education, Government of National Capital Territory of Delhi, Law Officer, Recruitment Rules 2018.
 - (ii) They shall come into force on the date of their publication in the official Gazette.
- Number of posts, its classification and pay level in the pay matrix: The number of said post, its
 classification and pay scale of pay attached thereto shall be as specified in Columns 2 to 4 of the Schedule
 annexed to these rules.
- Method of recruitment, age limit, qualifications etc:- The method of recruitment, age limit, qualifications and
 other matters relating to the said posts, shall be as specified in the Columns 5 to 13 of the said Schedule.
- 4. Disqualification- No Person
 - (a) Who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax: Where the Government is of opinion that if necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, may relax any of the provision of these rules with respect to any class or category of persons.
- 6. Saving:- Nothing in these rules shall effect reservations, relaxations of age limit and other concessions required to be provided for the Scheduled Castes, the Schedule Tribes, Ex-servicemen, Other Backward Classes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
