The timelines for registration of school/institutes is fixed latest by 31.08.2019 by the Ministry. The District Nodal Officers may kindly be directed to ensure that the timelines are met.

Therefore, you are requested to issue necessary directions to the concerned Officers dealing with the Scholarship Schemes of the Ministry for immediate action in this regard, registration of Schools/Institutes on priority basis, also due emphasis may be given on proper advertisement/publicity through print media and other modes of campaign of these schemes.

National Workshop on implementation of 3 Scholarship Schemes for Minorities through the National Scholarship Portal (NSP)- reg.

Sir/Madam

As you are aware Ministry of Minority Affairs organised the 1st National Workshop of this year on the implementation of 3 Scholarship Schemes on 19.08.2018. Despite intimating the States about the workshop sufficiently in advance the participation was much less than anticipated and there were very few District Nodal Officers (DNO). Nomination of DNOs by the States/UTs and registration of Schools/Institutes on the Portal are two very critical factors on which the success of the timely distribution of Scholarship rests. Low performance on both accounts is a cause of serious concern.

- 2. These delays have resulted in far less number of applicants registering under the 3 Schemes on the portal, compared to the number of registrations during the same period of time last year. The States/UTs participating in the National Workshop on 19.8.2019 have committed to complete the nomination of District Nodal Officers by 23.08.2019 and the registration of schools/institutes latest by 31.08.2019. The State Nodal Officers (SNOs) may kindly be directed to ensure that the timelines are met.
- 3. This Ministry organises Workshops to address issues faced by the States/UTs in implementing the Scholarship Schemes. Many of these issues were discussed and resolved in the 1<sup>st</sup> National Workshop held on 19.08.2019. This would be followed up by regional Workshops with focus on a cluster of States/UTs to resolve their specific issues. I would urge that the SNOs may be directed to list out issues pertaining to your State/UT and send it across to us to enable us to resolve the same.
- 4. States and UTs are advised to give wide publicity to these Schemes through print media and other modes of campaign. Each State/UT should also hold internal workshops/camps to ensure that no difficulties are faced in implementing the Schemes at District/level.

4. As you are all aware that empowerment through education is one of the focus areas' of this Government and we are committed to substantially increase the number of beneficiaries under the 3 Scholarship Schemes in the next five years. However achieving this objective would be possible only with the co-operation and commitment of the States/UTs.



Sir/Madam.

Kindly refer to the D.O. letter of even number dated 05.07.2019 from Secretary (Minority Affairs) and my letter No. 8-4/2019-SS dated 17.07.2019, both addressed to Chief Secretary/Administrator of all States/UTs regarding implementation of three Scholarship Schemes of this Ministry viz. Pre-Matric, Post-Matric and Merit-cum-Means for the six notified minority communities during 2019-20 through the National Scholarship Portal (NSP). The NSP has been opened from 15.07.2019 for submission of online application in any of the three Schemes by eligible candidates. In order to avoid delay and ensure timely disbursal of Scholarship the cooperation of the States/UTs is once again solicited and the following is brought to your attention for immediate action:

• The details of State/UT Nodal Officer (Scheme-wise), as confirmed by the States/UTs, have been uploaded on the NSP. The details of the District Nodal Officer (Scheme-wise) are also to be uploaded to facilitate verification of School/Institute level Nodal Officers for 2019-20 as well as for the verification of applications where District is the second level verifying authority. Hence the State Nodal Officer may kindly be directed to update the requisite information in respect of their District Nodal Officer, Scheme-wise immediately. In this regard a provision has been made available on NSP to verify the District Nodal Officer.

- A copy of the advertisement issued by the State/UT may kindly be furnished. A template
  has already been provided by the Ministry for this purpose.
- The status of registration of Institutes, verified by the District/State Nodal Officer, as available on NSP as on 26.7.2019 is enclosed. It may be seen that the number of Institutes registered so far is very low even after 2 weeks of the opening of the Portal. The State Nodal Officers/District Nodal Officers may kindly be directed to expedite the registration of the Institutes on priority basis. Also due emphasis may be given on proper advertisement and publicity of these Schemes.
