
Sub:- U-DISE Code implementation in online registration of schools under INSPIRE Awards-Manak.

'National Innovation Foundation-India' an autonomous body of Department of Science & Technology(DST), Govt. of India has decided to include U-DISE Code (Unified-District Information System for Education) mandatory for the school details as it's a unique code, different for every school.

In order to implement this, all schools (Govt./Aided/Unaided recognized Schools) registered on the E-MIAS must include/update their U-DISE Code by login in the portal. U-DISE shall be mandatory for all new registrations in case of an un-registered school.

In view of the above, all school (Govt./Aided/Unaided recognized) HoS are hereby directed to update the details in r/o U-DISE, e-mail verification and other detail etc. on the E-MIAS portal with immediate effect.



Dear Mrs. Setia Ji,

I would like to extend my heartfelt gratitude towards you for your continued support and co-operation for the implementation of INSPIRE Awards – MANAK scheme in your state. During the State Nodal Officers meeting held at IIC, New Delhi on 5th July, 2019 the issue of duplication (multiple application numbers) of schools in the E-MIAS (www.inspireawards-dst.gov.in) and problem in retrieving the user id and password by the schools was discussed.

To simplify the process, it has been decided to include U-DISE Code (Unified District Information System for Education) mandatory for the school details as it is a unique code, different for every school.

In order to implement this, all schools (all government or private, aided or unaided, from any National or State Education Board) registered on the E-MIAS must include/update their U-DISE Code by login in the portal. U-DISE shall be mandatory for all new registrations in case of unregistered school.

You are requested to kindly instruct the Districts and School Authorities accordingly so that they can complete their updation (U-DISE, e-mail verification and other important details etc.) as soon as possible on the E-MIAS portal.
