**Sub.: Extension of license period for sale of liquor under L-1/L-1F and L-2 (Draught Beer) License up to 31.07.2019.**

In accordance with the provision of Rule 34 of Delhi Excise Rules, 2010, the Competent Authority has approved the extension of validity of existing L-1/L-1F/L-2 licences for the sale of liquor brands registered as per approved terms and conditions for 2018-19 at their existing price up to 31.07.2019.

The L-1/L-1F/L-2 licensees who are willing to avail of this extension period of 01 month from 01.07.2019 to 31.07.2019 to make sales of their registered brands at existing price. are required to deposit 01 month fees i.e License fee, Label Registration fee, BWH fee and any/all other fees as applicable to L-1/L-1F/L-2 licenses on pro-rata basis for a period of 01 month in advance.

However, any person holding such non-renewable license shall not be under any obligation to accept such offer to extend his licence.
