The application for inclusion in electoral roll may be made in Form-6, deletion of an existing entry from the electoral roll in Form-7, correction in existing entry in Form-8 and change of address within same Assembly Constituency in Form-8A. All these forms can be downloaded from the website of Office of the Chief Electoral Office www.ceodelhi.gov.in. Further, the application in concerned Form may also be made online at www.nvsp.in
