Sub:- **Payment of Dearness Relief on Pension to re-employed pensioners of Govt. of NCT of Delhi.**

Sir,

The Directorate of Education, GNCTD have issued instructions for payment of Dearness Allowance on Net Pay instead of Gross Pay to the re-employed teachers w.e.f. 01.04.2018. Re-employed teachers would continue to draw Dearness Relief on Pension through the Bank from where they are drawing their monthly pensions.

2. In this context, it is informed that at the initial stage of issue the Pension Payment Order (PPO), PAOs have issued the pension payment authority mentioning therein that (Dearness on Pension) from time to time would be payable. In certain cases at the time of revision of pension of such re-employed teachers w.e.f. 01.01.2016 certain PAOs have mentioned that Dearness Relief during re-employment period would not be admissible.

3. This office has issued instructions to all PAOs vide letter dated 25.09.2018 (copy enclosed) that in those cases where at the time of revision of pension w.e.f. 01.01.2016, if the fact of non-payment of Dearness Relief on Pension has been mentioned in the revised pension authority, instructions may be issued to the office of CPAO for payment of Dearness Relief on Pension to such pensioners w.e.f. 01.04.2018.


4. A number of representations are being received in this office where pensioners are representing regarding non-payment of Dearness Relief on Pension by the banks. Such pensioners have since given in writing to the respective bank branches for non drawl of Dearness Relief on Pension during re-employment period, a certificate by the Head of Office regarding payment of DA on Net Pay w.e.f. 01.04.2018 would be sufficient instead of insisting upon a fresh revised authority in those cases where PAO has not specifically issued authorities for non-payment of Dearness Relief on Pension during re-employment period.

5. In view of above, you are requested to consider the above and issue necessary instructions to the banks for releasing Dearness Relief on Pension to re-employed teachers of Directorate of Education, Govt. of NCT of Delhi w.e.f. 01.04.2018. Controller of Accounts, Directorate of Education, GNCT of Delhi has also provided the necessary information as sought by your office vide letter No. F.3(8)/AO-II/Misc/2018-19/539 dated 13.09.2018 (copy enclosed).

6. This issues with the approval of Controller of Accounts.


