

Subject: Observations on the Pension Payment Orders

Sir,

Please refer to your office letter No. F.12(04)/2018/T-I/Pr.AO/1401 dated 19.07.2018 on the subject mentioned above. In this connection, point wise reply on the observation raised by your office is given below:

S. No	Observation	Reply
1.	Where pension is authorized to the eligible children by issuing fresh PPO a certificate is being insisted upon to the effect that existing PPO issued in favour of the pensioners/family pensioners has been cancelled.	A certificate is required to discontinue/delete the old PPO No. from PARAS database of the CPAO to avoid the over payment/excess payment/fraudulent pension/ double family pension against one old PPO and another new PPO.
2.	Certificate to the effect that payment of additional amount of DCRG, commutation of pension has been paid through Head of Office in those cases where payment of pension through Bank has already been commenced.	Certificate is required to avoid double payment of Commuted value of pension and additional amount of DCRG.
3.	Stamp of PAO affixed on the photograph of the pensioner is either dark or on the upper area of the photograph of the pensioner/family pensioner.	Instructions issued by M/o Personnel, Public Grievances and Pensions, Department of Pension and Pensioners Welfare, O M No. 4/13/2018- P &PW (D) dated 06.04.2018 while furnishing photographs may be adhered to.
