
Sir/Madam,

Kindly refer to the above.

2. In this connection, it is to inform you that there is a huge outstanding demand is reflecting on TRACES which are pending for a long time and no one is taking any attention towards the payment of the pending demand despite issuance of several notices to the concerned schools.

3. It has come to the notice during seminars which were organized by the CPC-TDS, Vaishali, Ghaziabad and the undersigned on 31.08.2018 and 10.12.2018 respectively. Several representations have been received in black and white as well as problems/questions raised/put which have been faced during the rectification of the demand before the CIT(TDS) and CIT-CPC(TDS) during the seminars by the representatives of the schools and other organizations.

4. On perusal of the representations and listening to the problems/questions raised /put during the seminars, it is observed that there is a need to take concrete as well as proactive steps to liquidate the outstanding demands. The work of liquidation of pending outstanding demand on TRACES cannot be completed without your cooperation.

5. It is, therefore, requested to kindly communicate to the PAOs to cooperate with their schools and enable the undersigned to reduce the huge outstanding demand pending on TRACES by **15.01.2019** & kindly mark the copy to undersigned as well.
