Sub: Guidelines regarding grant of Vigilance Clearance/Vigilance Status Report.

In accordance with the guidelines issued by DOPT/GOI vide OM No.110012/11/2007/Esstt.(A) dated 04.12.2007, No. 104/332005-ADV.I dated 29.10.2007, F.N 22034/2012 Estt (D) dated 02.11.2012, No.11012/11/2007-Estt.A dated 21.06.2013 regarding grant of vigilance clearance/status to member of central civil Services/Central Civil Posts, AIS Officers, Ex-carders Gazette Officers/Non Gazette Officers/Officials, DANICS, Ad-hoc DANICS and DASS Cadre, Cadre Gazette Officers/Non Gazette Officer/Official posted in Social Welfare Department, the vigilance clearance/status is required to be issued in all cases with the approval of the Head of vigilance of the Department.

In view of the above guidelines, so far as the Department of Social Welfare is concerned, the Competent Authority for grant of vigilance clearance/status in respect of various categories of officers is proposed as given below:-

S.No.	Competent Authority	Officers in respect of whom vigilance report can be granted
1	Spl. Director/Joint Director/Head of Office	All Non-gazette Officers/Officials (DASS and Ex-cadre)
2	Director	All gazette officers (i) Ex-cadre (ii) DASS Cadre
3	Secretary	(I) All DANICS officers upto the rank of Dy. Director and above. (II) HODs.


