Whereas, modified estimate received from Superintendent Engineer Shahdara M-23's of **Rs.6,96,96,500 (Rupees Six Crore Ninety Six Lac Ninety Six Thousand Five Hundred only)** vide letter No-23 (101) Shadara M/PWD/2024 dated 21/7/2016 for construction of Old Age Home at Kanti Nagar, Shanti Mohalla, Gandhi Nagar, Delhi.

And whereas Department of Social Welfare, Govt of NCT of Delhi already conveyed administrative approval and expenditure sanction for **Rs. 5,78,83,000- (Rs. Five Crore Seventy Eight Lac Eighty Three Thousands only)** for construction of Old Age Home at Kanti Nagar, Shanti Mohalla, Gandhi Nagar, Delhi vide No. No. F.54 (123)DSW/EC/2000-01/Pt.file/14084-098 dated: 17/09/2015.

Now, I am directed to convey the administrative approval and expenditure sanction of the Secretary, Department of Social Welfare, Govt of NCT of Delhi for the additional amount i.e. Rs.6,96,96,500-Rs.5,78,83,000=**Rs. 1,18,13,500/- (Rupees One Crore Eighteen Lakh Thirteen Thousand Five Hundred only)** for carrying out above said works. Further the expenditure on the project till its completion will remain restricted to the approved outlay.

The sanction is further subject to the condition that all the codal formalities are adhered to. All guidelines issued by Central Vigilance Commission (CVC) for construction of building must be followed. It is added that the rates and other charges should not exceed the prescribed rate of the CPWA Manual. It may be ensured that there is no escalation of cost. PWD will be responsible for the quality of work and its completion on time apart from fulfilment of due procedure. **PWD is also required to submit a utilization/completion certificate after completion of the said works under reference.**
